## SUMMARY

From 06 July 2024, the layout limits that were introduced in 2020 will be enforced in Workspace. To aid the transition, the new Layout Manager tool is being introduced.

## DESCRIPTION

### What is the change?

In 2020, to safeguard layout performance, limits were introduced for Workspace layouts, which restricted their configuration to the following:

- 10 sheets per Layout
- 10 panels per sheet
- 10 tabs per panel
- Maximum of 1000 apps in a Layout

This was introduced to limit the total number of apps in one tab, setting minimum performance benchmarks for layouts.

Since 2020, Workspace users who had layouts that break these limits, though were created before their introduction, will have had a warning banner in their layouts. This banner advised users of these limits and of the changes required for their layouts to perform optimally.

For Eikon users migrating  
*after 06 July 2024*

, their Eikon layouts and FlexSheets will be converted into Workspace layouts and subject to these limits.

From 06  
*July 2024*

, any Workspace layouts, whether migrated from Eikon or originating in Workspace, that exceed any of these limits will require adjustment in order to be usable. To support this adjustment, a new Layout Manager tool will be shown in a side panel, adjacent to layouts that require adjustment. This tool will guide users through the process of optimizing their layout.

Users can still choose to:

- Group all content together, using a 'Collection' in My Files
- Bookmark any of these items in a group or individually, supporting a switch between items directly from their Browser toolbar.

**Why is the change occurring?**

Optimise layout performance.

**What is the impact of the change?**

Layouts may require adjustment.

**What action do you need to take?**

After June 2024, ensure all layouts you are using in Workspace conform to the stated limitations.
