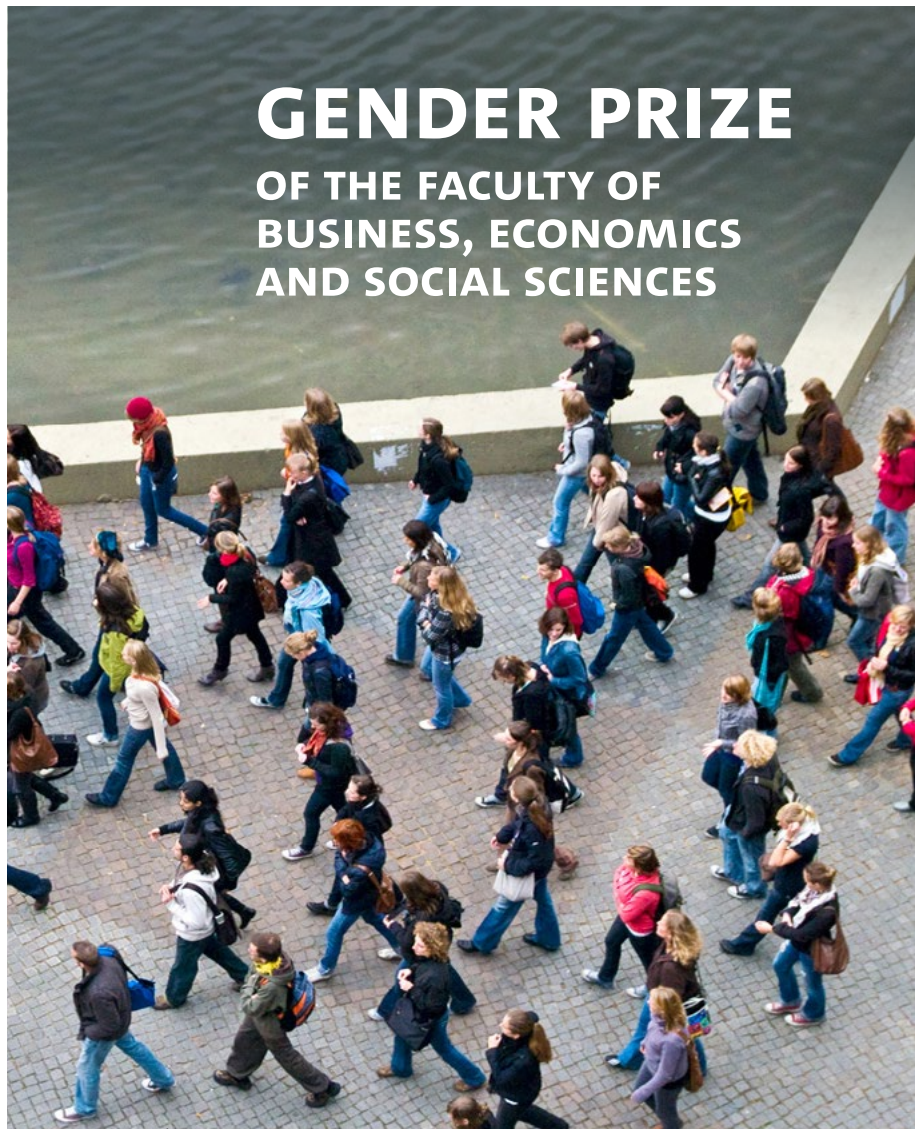

CALL FOR APPLICATIONS

The Faculty of Business, Economics and Social Sciences strives to acknowledge graduates, doctoral students and research associates, who have considered gender issues in their final thesis, doctoral dissertation, or a paper, by conferring gender prizes.

Four prizes are awarded annually for, respectively:

- a doctoral dissertation in the amount of €800
- a paper in the amount of €300
- a master's thesis in the amount of €500
- a bachelor's thesis in the amount of €300

The prizes will be awarded to outstanding final theses and doctoral dissertations completed between 16 May of the previous year and 31 May of the current year.

The following are eligible to apply:

I. Graduates who wrote their final thesis at the Faculty of Business, Economics and Social Sciences and were awarded the grade of “Very good”; or their assessors. The final thesis must be completed by the application deadline and an assessment must be available.

II. Doctoral students who wrote their dissertation at the Faculty of Business, Economics and Social Sciences and were awarded the grade of “summa cum laude” or “magna cum laude”; or their assessors. The doctoral dissertation must have been completed between 16 May of the previous year and 31 May of the current year and an assessment must be available.

III. Research associates in the Faculty of Business, Economics and Social Sciences who have submitted or published a paper with links to gender topics between 16 May of the previous year and 31 May of the current year. The criteria for papers set forth in the faculty's doctoral degree regulations apply.

Selection and use of funds:

Selection: the prizewinners are selected by the dean based on the recommendations of a jury.

Use of funds: prizes are awarded in the form of book vouchers, travel vouchers (if not employed at UHH), sustainable vouchers. Universität Hamburg staff receive covering of travelling expenses or the covering of expenses and/or a subsidy for printing academic work, participation in conferences, congresses, or similar. For legal reasons, prize money cannot be paid out in cash.

For legal reasons, former employees of the University of Hamburg (UHH) cannot receive prize money.
