## EQUAL OPPORTUNITY FUND 2020

---

The Faculty of Business, Economics and Social Sciences strives to support and fund outstanding projects furthering equal opportunity in research and teaching. For this purpose, an Equal Opportunity Fund with €5,000 is being made available in 2020.

This fund will finance projects and measures serving equal opportunity for women and men and eliminating gender discrimination in research, teaching, and studies.

### **SELECTION:**

The dean decides on the awarding of funding based on the recommendations of a selection panel.

### **USE OF FUNDS:**

Funds can be used to finance student assistants, for example, or to procure relevant literature. For funds to be paid to parties external to Universität Hamburg, evidence must be provided of the specific benefits for the University (e.g., use of prize money to attend conferences).

For legal reasons, funds cannot be paid out in cash.

### **The following are eligible for funding:**

- scientific projects and studies on gender-related topics and equal opportunity
- classes on gender-related topics and equal opportunity
- projects to help reconcile work and family commitments

The projects/measures must be implemented or at least begun at the Faculty of Business, Economics and Social Sciences between 1 July 2020 and 30 June 2021. The gender-specific relevance must be clear.

University teachers and research associates working within the Faculty are eligible to apply.

### **Applications must include:**

- details of the responsible person(s) and those involved in the project/measure
- justification of eligibility for funding according to the above criteria
- project/measure time frame
- for scientific projects: outline of existing findings (max. 1 page)
- for projects to help reconcile work and family commitments: progress report and findings (max. 1 page)
- detailed budget plan (where necessary, incl. a statement on attempts to secure funding from other sources)
- project plan and timetable
