# PUBLISHING YOUR DISSERTATION

Publishing your dissertation is an integral part of the doctoral procedure. There are several ways you can do this:

1. With a publishing house
2. Electronically via the State and University Library Hamburg
3. As journal articles (dissertations by publication)
4. Self-publishing

## PUBLICATION APPROVAL

Pursuant to the doctoral degree regulations dated 2010 and 2017 (PromO 2010 and PromO 2017), successful completion of the oral defense counts as permission to publish the dissertation. For doctoral procedures pursuant to PromO 1998, PromO 2000, or the former doctoral degree regulations for the Hamburg University of Economics and Politics (HWP-Ordnung) dated 1989, the first reviewer must approve the dissertation in writing before it is published.

## PUBLICATION DEADLINES

The deadlines for the publication of dissertations are as follows:

If the dissertation cannot be published within the set time frame, the doctoral committee chairperson may grant an extension upon submission of a well-grounded request.

## 1. PUBLISHING WITH A PUBLISHING HOUSE

The minimum number of copies of an edition is sixty-five. The State and University Library Hamburg should receive five and the Graduate School one copy.

## 2. PUBLISHING ELECTRONICALLY VIA THE STATE AND UNIVERSITY LIBRARY HAMBURG

The dissertation can also be published electronically via the State and University Library Hamburg. To do this, contact Theses and Dissertations Handling at the State Library (see overleaf for the contact details) and request access to the dissertation server. If you have a valid library card, you can log in with your ID number and password. Then upload your dissertation and complete the publication agreement.

In addition to uploading your dissertation, you are required to deposit two paper copies with the State and University Library and one copy with the Graduate School.

## 3. PUBLISHING A DISSERTATION BY PUBLICATION AS JOURNAL ARTICLES

a) As the contents of a dissertation by publication are available to the public as journal articles, an additional publication is not necessary if **all of the articles have already been published**. Four paper copies (print copies) of the complete dissertation by publication must be deposited with the State and University Library and one copy with the Graduate School.

b) If one or more of the articles has **not yet been published**, but is expected to be published in a journal, then you may request that the article(s) be published electronically by the State Library. As long as the article has not yet been

published in the journal, the electronic version will be temporarily withheld in the State Library's inaccessible area. The electronic version will not be submitted to the German National Library or listed in the Common Union Catalogue. If no other arrangements have been made, the two print copies will be cataloged and made available for use in the State Library. The dissertation is then given the status of published—even though it will initially only be cataloged in the State Library.

## 4. SELF-PUBLISHING

The minimum number of copies of an edition is sixty-seven. Of these, sixty-five copies must be submitted to the State and University Library Hamburg and one copy to the Graduate School.

## PAPER COPIES

Regardless of the manner of publication, paper copies of the dissertation must always be submitted to the State and University Library Hamburg and to the Graduate School.

The paper copies contain the dissertation title page (see the templates on the Graduate School homepage). Dissertations by publication must contain all of the articles for the dissertation by publication along with the synthesized chapter described in the doctoral degree regulations. The copies must be bound in the usual manner.

The copies submitted must indicate the journal and date of publication for each article included.

All paper copies must be printed on non-aging, acid-free paper and submitted bound in the usual manner (e.g., adhesive binding or sewn binding). Ring binding or spiral binding will not be accepted!
