



# Towards a convivial economy? Theoretical perspectives and practical experience

Workshop organised by Frank Adloff & Philipp Degens (University of Hamburg), Peter Heller (Canopus Foundation), and Rupert Graf Strachwitz (Maecenata Institute for Philanthropy and Civil Society)

Recently, debates on alternative forms of living together *(con-vivere)* have been invigorated by the concept of convivialism and particularly by the publication of the convivialist manifesto in 2013. Convivial practices aim for coexistence on a non-competitive basis, both within and beyond societies. Such practices involve searching for forms of prosperity without growth, allowing humans to take care of each other and of nature. It seems obvious that such a convivial society needs to be grounded on an alternative form of the economy; and such an economy, in turn, requires a different kind of society.

In the workshop, we will discuss questions such as:

- How might the economy be constructed in a way that is socially just and ecologically sustainable?
- How should a convivial economy be embedded in society?
- What steps might lead to a convivial alternative?

Within state and business such questions are not addressed sufficiently. We therefore include perspectives and innovative impulses from civil society actors. The workshop brings together French proponents of convivialism with German representatives of alternative economic concepts and practices.
