Wolfgang Habla, ZEW:

Strategic delegation and centralized climate policy

Abstract:

We analyse a typical principal-agent relationship in the context of international environmental agreements. First, the principals delegate the authority to negotiate an agreement to an agent each, who acts on their behalf. Second, the appointed agents bargain over the total level of emissions and the allocation of permits. In the last stage, emission permits are traded. Solving by backwards induction and using the Nash-Bargaining Solution, we find that despite the strategic considerations in the choice of the delegates, global emissions are lower under cooperation in comparison to non-cooperative policies. Furthermore, for cooperation to be mutually beneficial for both principals, their countries need to be sufficiently symmetric.

Nowcasting GDP with Artificial Neural Networks

Abstract:

We use a machine learning approach to forecast the US GDP value of the current quarter. Within each quarter, the contemporaneous value of GDP growth is not available, but can be estimated using higher-frequency variables that are published in a more timely manner. Using the monthly FRED-MD database, we compare the feedforward artificial neural network forecasts of GDP growth to forecasts of state of the art dynamic factor models and evaluate the relative performance.

Paolo Piacquadio, University of Oslo:

Individual and Social Deprivation when Choices Matter

Abstract:

Choices are fundamental in explaining differences in the attainments of individuals. This paper addresses the challenge of measuring individual and social deprivation, when keeping individuals responsible for their choices. I show that intuitive principles of distributive justice force social deprivation to be measured by the sum of specific indices of individual deprivation which: (i) respect the preferences of individuals; (ii) compare individuals based on the set of attainments they are deprived of; and (iii) are continuous and convex. Furthermore, I extend the characterization results to differences in needs and categorical dimensions of deprivation and illustrate the criteria using the Norwegian register data.
