Redesigning payment systems to reduce health inequality

Abstract:

Socioeconomic inequality in health is a policy concern in many countries. Yet, strategies to reduce health inequalities have paid little attention to payment systems for health care providers. In this talk I will present the results of a study which sought to develop a methodology to set 'equity-sensitive' payments for health care services designed to incentivise reductions in socioeconomic inequalities in health. We provide quantitative evidence on the current level and distribution of health benefits from care provided under the Quality Outcome Framework (QOF) - a large national P4P programme - and how changes to QOF incentive payments are expected to change health inequality across socioeconomic groups.

Unintended Trade-Offs of Inclusivity: How Gender Policies Reshape Bureaucratic Careers

Abstract:

This paper investigates the unintended trade-offs of identity-based policies on diversity, regional equity, and institutional cohesion in the All-Pakistan Service. Exploiting a gender-sensitive policy introduced in 2000 as a natural experiment, I analyse a panel dataset of deputy ministers' postings and career trajectories from 1985 to 2020. Using Triple Differences designs, I show that while the policy successfully increased women's participation in leadership positions, it diminished representation from minority provinces and deepened regional imbalances. By shifting cross-regional mobility patterns and consolidating provincial dominance, the policy converted inclusivity into a zero-sum game, undermining the integrative objectives of the All-Pakistan Service. These findings reveal the structural challenges of crafting representation policies that achieve equity without sacrificing cohesion, providing empirical evidence of the delicate balance required in designing inclusive institutions.

Explanatory Norms and Interdisciplinary Collaboration

Abstract:

This paper provides resources from the philosophy of science to identify differences between explanatory norms across disciplines and to examine their impact on interdisciplinary work. While the body of literature on explanatory norms is expanding rapidly, a consensus on a theoretical framework for systematically identifying norms across disciplines has yet to be reached. The aims of this paper are twofold: (i) to provide such a framework and use it to identify and compare explanatory norms across different domains; and (ii) to derive indications about interdisciplinary practice accordingly. By pursuing these goals, this work aims to be both theoretically significant and practically relevant. It contributes to the ongoing work on explanatory norms; and offers recommendations for the analysis of interdisciplinary science.
