The position in accordance with Section 28 subsection 1 of the Hamburg higher education act (Hamburgisches Hochschulgesetz, HmbHG) commences on 15th October 2020.

This is a fixed term contract in accordance with Section 2 of the academic fixed-term labor contract act (Wissenschaftszeitvertragsgesetz, WissZeitVG). The initial fixed term is three years. The position calls for 75% of standard work hours per week.*

RESPONSIBILITIES:

Research associates will be expected primarily to teach and conduct research. The research associate will also have the opportunity to pursue further academic qualifications, in particular a doctoral dissertation. At least one-third of set working hours will be made available for the research associate's own academic work.

SPECIFIC DUTIES:

The research associate has a research interest in dynamic macro theory, financial markets or stochastic processes and should pursue independent research. He or she has excellent knowledge in statistical or numerical software (e.g. Matlab, R or similar). The ideal research associate should contribute to the research area on the "Interaction of fiscal policy, central banks and financial markets". The teaching load is 3 hours per week per semester.

REQUIREMENTS:

A university degree in a relevant field. Applicants should submit two letters of recommendation from a university professor or lecturer, which in particular evaluate the applicant's ability for a PhD position.

* Full-time positions currently comprise 39 hours per week.
