O1 WISO RESEARCH LAB FEES

The following fees are charged for the use of the WISO Research Lab (RL). Fee amounts are determined according to the type of use (internal and external use).

Internal Universität Hamburg use of the WISO-RL is defined as use by members of Universität Hamburg that is financed from budgetary funds or external funds expended through Universität Hamburg.

External Universität Hamburg use of the WISO-RL is defined as a use by individuals who are not members of Universität Hamburg and whose use is funded by resources other than Universität Hamburg budgetary funds or external funds expended through Universität Hamburg. Similarly, external use of the WISO-RL is also defined as a use by members of Universität Hamburg, financed by funds that do not come from Universität Hamburg budget appropriations or external funds expended through Universität Hamburg.

O1.1 FEES FOR SPECIFIC RESEARCH EQUIPMENT (SPECIFIC RESEARCH FACILITY, SRF)

Use of RL specific research equipment (SRF) is generally subject to reimbursement based on type and duration of use:

O2.1 COMPENSATION FOR TEST SUBJECTS (PAYOUTS)

Users must generally directly remunerate participants or test subjects for their participation in the RL (payout). Payment recipients must acknowledge receipt thereof in writing. If the RL processes these payouts, the user must fully reimburse the RL for any funds it advances and accounts for as a transitory item for this purpose, and must also pay the relevant processing-of-payments fee. Incentive, success, and punctuality bonuses for test subjects are covered in more detail in the RL's Rules of Use.

O3 FEES FOR SERVICES FINANCED BY SPECIAL EXTERNAL-FUNDING SOURCES (UNIVERSITÄT HAMBURG INTERNAL USE ONLY)

Internal Universität Hamburg users, financed by external funding and subject to guidelines that only allow funds to be used for project-specific costs (e.g., DFG), will be charged a flat-rate fee for use. Flat-rate fees for use are unit-based costs for a project or the respective additional service, determined on the basis of evidence within the framework of full cost accounting, and include project-specific personnel and material costs. Invoicing in accordance with Sections 1 and 2 of this Schedule of Fees will **not** be undertaken for these research projects.

O4 FEES FOR OTHER SERVICES

Generally, the following fees for standard processes are charged for the utilization of other specific RL research services. The fees listed are derived from the labor services associated with these standard processes as well as any costs for the specific service-related research equipment. In the case of additional effort and expense that deviates from the standard process, reimbursement shall be made according to the type and duration of the service rendered pursuant to the hourly rates set forth in Section 2 of this Schedule of Fees.

04.1 ADDITIONAL COSTS

Additional costs actually incurred through the use of the RL will be charged directly to the user and invoiced by the WISO-RL according to type and duration.

04.2 IDLE CAPACITY CANCELLATION FEE

If scheduled use cannot take place, RL staff must be informed without undue delay and no later than 10 workdays prior to the time reserved for use so that the time slot can be reallocated. Otherwise, an idle capacity cancellation fee equal to the scheduled SRP and staff hours may be charged.

O5 FINAL PROVISIONS

Statutory provisions apply unless otherwise provided for in this Schedule of Fees.

This Schedule of Fees becomes effective on 15 April 2021 according to the resolution adopted by the WISO office of the dean on 13 April 2021.
