APPLICATION AND ADMISSION PROCEDURE

Application period: 15 February to 31 March.

Program start: once per year in October.

Admission quota: 60 study places (30 places for applicants with an educational background in Germany, 30 places for applicants with an educational background from outside of Germany).

ADMISSION REQUIREMENTS

University degree: Outstanding results in undergraduate university degree of at least six semesters (180 ECTS) in economics, law or social sciences. Students should have above-average grades and demonstrate a high degree of motivation for pursuing the program.Further information available at: www.wiso.uni-hamburg.de/mibas

Language skills: proof of adequate English proficiency

SELECTION PROCESS

Applicants are ranked within their group according to the following criteria:

- grade achieved in first degree (weighted with 60%)
- written justification for chosen program (weighted with 40%)
